CRICKET- Kent Rainbow, President of Cricket Supporters Association has resigned

RUGBY

- RSG met on 10 February with 18 attendees (2 staff members, 2 members of Iconz Rugby), and 11 apologies.
- Andrew Curtain & Manuel Cole-Manolis of Iconz Rugby have taken on the role of MS development (funded by RSG -\$2000).
- Merchandise scarves (\$15), cooler bags (\$10) & car stickers (\$2) are all for sale on Flexischools.
- $\circ~$ A number of volunteers and students ran the BBQ at the welcome event.
- The launch of Rugby 2014 encouraged all teams to train on 19/02 and then watch the Head of Rugby XV v the Head of Sport Development XV, the initial of a series of 1st XV trials. We have had positive feedback about the spirit of the event; thanks to all staff & parents helpers, especially the ground staff who did extra work needed to let the boys wear boots, as opposed to the original suggestion of trainers. The whole school community was invited and about 200 hungry mouths were fed.
- A smart rugby course is being held at school on March 3, as the qualification is mandatory for all school coaches.
- \circ The opens squad travels to MFAC on Sunday April 6 to participate in the Easter

Carnival & then 3 squads (opens, U16 & U14) travel on the Monday for games. There will be the traditional Rugby Camp at school on Tuesday April 8 catered for by the RSG. Training Shirts will be given to all players signed up by Camp on 08/04; to date we have 148 sign ons.

- All teams have coaches+/- an assistant/staff manager and all but the yr 6 team have PTC. Phillip Roxburgh is working on the Rugby Handbook.
- For the age 5-7 the Little Legends be will run by QRU after school on Mondays from April dates tbc. As the 8 year olds in year 3 are not allowed to participate (QRU ruling) they will be able to attend the year 4 training. They will only be allowed to play in the year 4 team if there are inadequate correct age players to field a team.
- $\circ~$ The yr 4 JTAS team will play in the year 4 carnival shirts, endorsed by Mrs. Connolly.
- Pink Day 01/06 orders for caps & socks are on Flexischools; please support a great cause. We may have pink helium filled balloons for sale.
- Finances reconciled with final Association report for 2013 \$19 464.19 For 2014 income \$1300 from Holt Bolt, \$74.00 from sticker sales; expenditure \$1500.00 to yr 9 tour, \$1000 deposit to Eatons Hill for 2014 RSG dinner; available funds \$2292.14. With only 3 home games for 2014 RSG are keen to secure an extra canteen such as the Met North Cross-country.
- $\circ~$ The yr 9 tour to Northern NSW is progressing.
- We are keen to hear the 2015 Opens tour to NZ can progress, mindful the November 2013 RSG meeting was given reassurance the tour was approved
- 2015 Opens Tour approval from school for 2015 opens tour, which would be available to the current yr 9 & 10, both groups who had experienced Year 9 tours. A few ideas have been circulated but a minimum of 25 kids would be needed at the expression of interest stage mindful students drop pout for a variety of reasons. Timing is a challenge with the training necessary to get a team trained to be safe to tour pre-season potentially impacting on other term 1 sports.

It would appear that the formality of regular meetings and process fell down a little at Cadets over the last year or two, so we have some work to do to get ourselves organised. JSSG- The JSSG met on 6 February with 11 attendees and 6 apologies We closed 2013 with a balance of \$26,667.46. We will be reviewing expected commitments for 2014 at our next meeting so that we can assess how much we can formally set aside for a shade and shelter project.

We agreed, in principle, to fund the cubby house project (\$600) submitted by Charles Sweeney to The Association. There have been no objections to the proposal circulated after the meeting and we will ratify the expenditure next month.

We raised \$782 through the Uniform Swap in 2013 and approved an additional \$116 donation to the Smith Family, meaning that the full Swap proceeds have been donated to the Smith Family - Learning for Life and Learning Club programs.

We also approved donating \$160.65 to Ronald Macdonald House Charities from the final Movie Night BHP matched giving donation which was finally received.

Mrs Connolly has been talking to Tim Hughes about JTAS uniforms and participation and will be asking him to make a formal decision on both, which will be communicated to families, coaches, etc This conversation was in response to parent concerns about a lack of clarity and consistency on both issues.
