Cricket – Alan Deacon announced that Cricket sign on is up and running until August. 2018 Cricket Tour is still going ahead and all preparations are on track.

• Tennis – good performance overall. Busy term, with a successful boys TAS tennis team. JTAS next term.

Football – Peter Deane stated that Football had a good start to the term with Saturday 22 July 2017 being the first match of the season. Playing shirts were organised by the Football SG and were issued to the players. Peter stated that the Canteen on Saturday 22nd proved to be a somewhat quiet day. Peter stated that Bryson Stansfield puts the Newsletter out and distributes information very efficiently. There are now 8 schools participating in TAS. Peter enquired as to when St Paul's would be informed as to where the finals would be held this year. Dr Browning stated that we would be informed quite late in the season.

Peter stated that the electrical problem (appliances overloading system and tripping electricity off) in the canteen is somewhat troublesome.

Bryson Stansfield is heading up the Tour to New Zealand, all is on track and progressing well.

Music – Karen stated that is has been a quiet term from a fundraising point of view. Several bands will perform in Queen Street Mall this term. A Junior Ensembles concert to take place in September and Senior Ensembles in October.

JSSG – Viki Jankovic stated that Rag Tagd is now up and running in Junior School. Money is currently being saved in order to purchase air conditioners for the Junior School. Dale Roche advised Viki that he may be of assistance in purchasing the air conditioners as he has a connection with Fugitsu. CPL is also up and running.

Treasurer's Report: (as circulated) Sandra Stanley stated that the Cross Country carnival (held over 3 days) was a great success. Thank you to Samantha Gray for organising the running of the Sports Canteen over these 3 days. Sandra stated that a good profit was made so far, more funds to come in. Sandra reiterated that the May Treasurer's Report was circulated via email as was the June Report. All should be in possession of these reports. Profits from the Pink Day fund raising went to breast cancer charities. Sandra stated that Coffee Royal is up to date with paying their commissions over. These commissions are divided equally, 3 ways to the 3 sports per term. Sandra once again reiterated that there are unallocated funds ("Agent Credit 1") in miscellaneous account. It is still unknown as to who these funds belong to. Sandra handed out new NAB lodgement books (credit books) to each Supporter Group. Sandra stated that from her perspective the only outstanding item in Report are "Bribey Island Triathlon" Funds with regard to Netball Supporter Group. Sandra is currently working on that. Gerard stated that he appreciates the way in which Sandra documents and presents her Treasury Reports. Gerard stated that the Association makes their financial details available, and any feedback would be appreciated. Karen Mellor enquired as to whether the Supporter Groups would receive their grants this year. Sandra assured her that these grants will be paid at the end of the year to those qualifying groups. Special Business:

Sports Canteen – stainless steel preparation table – This table is needed in the Sports Canteen in order for volunteers to prepare food efficiently. Andrew Thomas stated that he would endeavour to source this table. Dale Roche offered his help in this regard, if needed.

PEC Storage for Supporter Groups – Gerard stated that JSSG raised security concerns regarding this storage facility. The Walker Centre storage facility could potentially have security concerns. Dannielle put forward to Gerard that JSSG would like some sort of secure lockable cage to store their belongings in. Gerard stated that he would discuss the concept of secure cages with Charles Sweeney.

Driveway – student carpark entrance off Attunga Street. Peter Deane enquired as to whether the potholes in this driveway could be fixed, as well as the considerable "drop-off" at the gate which creates somewhat of a bump in the road. Dr Browning state that he would discuss this problem with Charles Sweeney (Maintenance).

Rag Tagd (electronic garment tag) –Gerard stated that Danielle Page took Rag Tagd concept to the JSSG Committee. It was implemented in Junior School and is now up and running.

General Business

2017 Fair- Sarah Slade thanked the hardworking Fair Committee.

Fair update- Raffle sales very successful. Good response to sponsorships – more trickling in. Site map will be available on the day. Everything now coming together, website, banners etc. Will be a great day, interesting mix with an international feel. There is no stage as undercover area will be utilized.

Gerard Yorston attended a Fair Committee Meeting and stated that he is satisfied with the Fair Committee's progress. No money to be paid upfront to ride operators or to stall operators.

Sarah stated that volunteers will be needed on the day. Gerard suggested that perhaps the SPSSA could provide volunteers for the set up in the morning and dismantling in the evening. Volunteers as carpark attendants will also be needed.

Gerard stated that he was concerned about insurance in connection with the Fair, however, given the reduced risk involved this year, the decision about insurance could be left undecided until about 3 weeks out from Fair. The insurance in question is in regard to the unlikely event of the Fair being cancelled. St Paul's School already holds Public Liability Insurance.

Gerard will be attending the next Fair Meeting on 26 July 2017.

Flexischools – Peter Deane stated that by the end of the year Maree Deane will no longer be the Flexischools liaison person. Alan Deacon suggested that a school staff member might be better suited to take on this role rather than a parent on a volunteer basis. It becomes difficult to find a different volunteer on a regular basis to undertake this mammoth task. Dr Browning stated that he would discuss this with Chris Sweeney (member of staff) and requested that Maree Deane send him an email with the relevant documentation. Treasurer Sandra Stanley noted that the JSSG are paying a subscription for a CPL Forum named "mailchimp". Sandra asked Viki Jankovic to request her committee to cancel this subscription as JSSG no longer use this forum. School electronic sign main entrance – Dale Roche enquired as to whether this sign could be used for advertising. Gerard stated that Dale should speak to Dylan Malloch about his request as there are already some plans in the works. Blue Day Raffle – Peter Deane enquired as to whether there would be a Blue Day Raffle this term. Gerard stated that this raffle would be held over until term 4 because of the Fair raffle this term. Blue Day socks - Lorelle stated that the VSG would like to purchase socks for volleyball players this year. School bus - Suellen Rush enquired as to whether the school bus could be used to get students to sport venues on Saturday mornings as not all parents are able to transport their children on these mornings. Andrew Thomas stated that there would probably be rules and regulations as to how many hours the bus driver would have to be on duty to wait for all students to finish their games in order to be driven back to St Paul's School. The other guestion would be: who would be responsible for these students on that day, making sure they all find their way back on the bus and safely to Bald Hills. Dr Browning stated that the guestion of using the school bus on Saturday mornings has crossed his mind, however, it wouldn't be viable at the moment and there are also costs involved. It was stated that "car-pooling" amongst parents takes place on Saturday mornings to sporting venues. Holt Bolt event - Alan Deacon enquired as to how many participants are expected at the Holt bolt event on 10 September 2017 as CSG will be running the sports canteen on that day. Sandra advised Alan to contact Ash at Holt Bolt. Ash would be able to answer Alan's questions. Group emails - Gerard Yorston stated that if anyone was still having problems with their SG emails they are to let him know in order for him to rectify any problems. Fundraising – Gerard stated that one of the main topics discussed at the Executive Meetings is on the subject of fundraising. He stated that funds will be distributed to the Supporter Groups fairly. Gerard also indicated that the Executive Committee had made a decision to disperse a portion (yet to be decided) of profit from the State Cross Country to participating Supporters Groups Applications for membership and recording of new members: no applications on the night Next Meeting: Tuesday, 22nd August 2017

Junior School Supporters' Group

Our last two meetings we have really focused our discussions on reconnecting with the JS community. We feel that this is the most important avenue to focus on as it needs rebuilding. There is a lot of Term 3 (post fair) and Term 4 activities planned for the JS, such as our Disco Skating Night, the FOC Dance at the end of morphing week, camping is being planned and a movie night is still in the works. We have decided that we are going to forego our Term 3 carpark raffle, as we feel there is too much going on with the fair. There will be a teatowel fundraiser in Term 4.

Apart from events/activities we are also focusing community projects which could engage all year levels of the JS during break-times, such as a mural, or art project which would be focused, or based, around the 5 learning realms. This would encourage involvement, positivity and would fit in with the cross-year level structure of the new houses groups. Hopefully once the necessary parties have been spoken to and it's decided, agreed, and planned, this can be an ongoing activity. Once completed, we would like the artworks to be displayed on the blank walls of the JS buildings, or decending on the works in the gardenbeds that do not grow due to sun exposure, offering more of an insight into learning and making it more engaging for parents, also more inviting and colourful for visitors/future parents.

To continue with this theme, we have received feedback from teachers etc, that children are struggling with the concept of money. To help with this understanding, with the help of Justin Hill, we are going to be building a stall, which at this stage will be set-up once a term (for now) whereby children can sell and buy homebaked goods or toys. Students will use real money, and nothing will be an even number. This will also prepare students when they need to venture to the daunting tuckshop.

We are also introducing the Commonwealth Bank Dollarmites School Banking program Pre-Prep-6 as this provides a fun, interactive and engaging way for our students to learn about money and develop good saving habits. This will start after the fair. This is on a 12 month trial.
